

## PARKING RESTRICTIONS

1<sup>ST</sup> READING - 1-10-2026

- 1 – PARKING RVs, TRAVEL TRAILERS, MOTOR HOMES, CAMPERS, OR TRAILERS OF ANY TYPE ON INDIAN ROCKS COMMON PROPERTY IS PROHIBITED UNLESS IN AN APPROVED PARKING AREA. BOAT TRAILERS MAY BE PARKED IN DESIGNATED AREAS FOR THE PURPOSE OF LAUNCHING AND RETRIEVING BOATS FOR A TIME NOT TO EXCEED OVERNIGHT.
- 2 – PARKING RV's, TRAVEL TRAILERS, CAMPERS, BOAT TRAILERS, OPEN TRAILERS, CLOSED TRAILERS, OR ANY OTHER TYPE OF TRAILER THAT IS 25 FEET OR LESS IN USABLE TRAILER LENGTH, WITH UP TO 5 ADDITIONAL FEET PERMITTED FOR TONGUE OF TRAILER, AND HAVE A GVWR OF 20,000 LBS. OR LESS ARE PERMITTED IN INDIAN ROCKS.
- 3 – PARKING OF RV's, TRAVEL TRAILERS, CAMPERS, BOAT TRAILERS, OPEN TRAILERS, CLOSED TRAILERS, OR ANY OTHER TYPE OF TRAILER THAT IS GREATER THAN 25 FEET IN LENGTH IS PERMITTED, FOR A PERIOD NOT TO EXCEED 72 HOURS. A PARKING PERMIT MUST BE OBTAINED FROM THE OFFICE PRIOR TO PARKING SAID VEHICLE, OR TRAILER. A MAXIMUM OF 4 SUCH PERMITS ARE ALLOWED PER CALENDAR YEAR.
- 4 – NO VEHICLE WITH A GVWR OF GREATER THAN TEN TONS (20,000 LBS.) CAN BE STORED OR PARKED ON ANY LOT OR PARCEL OF LAND OF THE PROPERTIES WITHIN INDIAN ROCKS.
- 5 – STORAGE PODS USED FOR MOVING OR TEMPORARY STORAGE OF BELONGINGS CAN ONLY BE PARKED FOR UP TO 30 DAYS ON A PROPERTY OWNERS PROPERTY.
- 6 – DUMPSTERS USED FOR PURPOSES OTHER THAN NEW CONSTRUCTIONN CAN ONLY BE PARKED FOR UP TO 30 DAYS ON A PROPERTY OWNERS PROPERTY.
- 7 – ALL RVs, AND VEHICLES MUST BE REGISTERED WITH THE INDIAN ROCKS OFFICE, HAVE THE CURRENT YEARS HANG TAG, AND A CURRENT STATE REGISTRATION.
- 8 – A – NO SLEEPING/ OVERNIGHT LODGING IS PERMITTED IN ANY RV, OR TRAILER OF ANY TYPE WITHIN INDIAN ROCKS.
- 9 – CLASS 4 VEHICLES AND HIGHER ARE REQUIRED TO SHOW PROOF OF GVWR AND VEHICLE REGISTRATION WHEN OBTAINING INDIAN ROCKS HANG TAG.
- 10- VEHICLES AND TRAILERS OF ANY TYPE ARE NOT PERMITTED IN INDIAN ROCKS IF THEY HAVE ANY FORM OF VISIBLE ADVERTISING. THE ONLY EXCEPTION TO THIS RULE, IS IF THE VEHICLE IN QUESTION IS DRIVEN TO AND FROM WORK ON A REGULAR BASIS.
